Do you approve the amended Maskekosihk Enoch Cree Nation Election Law?

Information packages, which will include the Amended Enoch Cree Nation Election Law, and such other information as Enoch Cree Nation Chief & Council determines is useful will be provided to each Voter either in person or electronically by Enoch Cree Nation platforms, such as the Enoch Cree Nation website which is accessible to Enoch Cree Nation members only.

Mail in Ballots will be mailed to all eligible voters who reside off of the Enoch Cree Nation Reserve. The addresses used will be the most recent address provided by the Voter to Enoch Cree Nation membership.

AND FURTHER TAKE NOTICE that a Voters List can be available at the Enoch Cree Nation Membership Office with this Notice of Ratification Vote and available electronically. Sections 8.3 and 8.4 of the Ratification Regulations provide:

- 8.3 A Voter may apply to the Ratification Officer before the Voting Day to have the Voters List revised if such Voter believes that:
 - 8.3.1 the name of a Voter has been omitted from the Voters List; or
 - 8.3.2 The name of a Voter is incorrectly set out or should not be included on the Voters List.
- 8.4 A Voter may, before the close of the polls on the Voting Day, apply to the Ratification Officer to have his or her name added to the Voters List.
